Legislative Activities:

On May 7, 2018, the U.S. Senate passed the **Improving Access to Behavioral Health Information Technology Act (S. 1732)**, which would authorize the Centers for Medicare and Medicaid Services (CMS) to incentivize behavioral health providers to adopt electronic health records.

On May 9, 2018, the House companion bill, H.R. 3331, was referred to the House Committees on Energy and Commerce and Ways and Means. Sens. Sheldon Whitehouse (D-RI) and Rob Portman (R-OH) introduced the **Improving Access to Behavioral Health Information Technology Act** in the summer of 2017. Reps. Lynn Jenkins (R-KS-02) and Doris Matsui (D-CA-06) introduced the House version in the summer of 2017.

NASW is part of the Behavioral Health Information Technology (BHIT) Coalition, which is advocating for passage of this legislation.

Contact Your Members of Congress Regarding Funding for Aging Programs

The Older Americans Act (OAA) helps older adults to engage in their communities and to maintain and improve dignity, health, and independence. Services funded through the OAA include case management, elder abuse prevention, family caregiver supports, nutrition programs, transportation, and in-home assistance. Yet, the OAA has been underfunded for many years. In partnership with the Leadership Council of Aging Organizations and other groups, NASW has advocated consistently for OAA funding. Thanks to this persistence, funding for some OAA programs was increased or held steady in the omnibus funding legislation for fiscal year (FY) 2018. Send an e-mail to your members of Congress to underscore the importance of continued FY 19 funding for the OAA and other aging programs.

NASW sent an action alert to Advocacy Listserv members asking them to urge their members of Congress to vote no on the **Farm Bill (H.R. 2)**. On May 18, the House failed to pass H.R. 2, a bill that would have thrown millions of people off the Supplemental Nutrition Assistance Program (SNAP). There is a chance that the House will have a revote in June.

NASW attended a presentation on the status of the **Violence Against Women Act (VAWA)**. Staff from the office of Rep. Sheila Jackson Lee (D-TX-18) discussed the status of getting VAWA reauthorization introduced in the House. There are delays in getting the bill prioritized as well as concerns that there are policy disagreements among a few members about provisions in the current bill. Rep. Jackson Lee has a lead role in moving the bill forward. VAWA is priority legislation for NASW.

Staff represented NASW in testifying on a panel of the **House Committee on Education and the Workforce's Roundtable Discussion on the Opioid Epidemic**. NASW testimony covered the need for child welfare services for families directly impacted by opioid abuse and addiction. Additionally staff discussed related health, behavioral health and policy implications of opioid abuse and use.

NASW continues to monitor Congress' activity as they work to address the opioid epidemic. In the Senate Health, Education, Labor, and Pension (HELP) Committee, they marked up and reported out of Committee <u>S.2680: The Opioid Crisis Response Act of 2018</u>, a comprehensive package made up of 40 different proposals. On Wednesday, May 23, the Senate Finance Committee released their <u>22 bipartisan opioid related bills</u> and are hoping to mark up these pieces of legislation in the coming weeks. These 22 bills encompass ways of incorporating telehealth into treatment, informing seniors about opioids, providing comprehensive screenings and review of current opioid prescriptions for seniors, improving access to care for women, babies, and infants impacted by substance use disorder, among others legislative efforts aimed at addressing the opioid epidemic.

Over in the House, the Energy and Commerce Committee has advanced <u>57 bills</u> offering a wide range of solutions to this public health crisis, including, but not limited to:

- *H.R. 3192- CHIP Mental Health Parity Act*: Requires all CHIP plans to cover treatment of mental illness and substance use disorders.
- *H.R. 1925, At-Risk Youth Medicaid Protection Act of 2017*: Prohibits state Medicaid programs from terminating a juvenile's medical assistance eligibility because the juvenile is incarcerated.

On May 16, the <u>House Ways and Means Committee</u> also marked up bills to combat this epidemic. A vote on opioid legislation in the House could come as early as the week of June 11.

Key NASW Legislation:

NASW continues to advocate for the **bipartisan legislation S. 2613 – Improving Access to Mental Health Act** introduced by Sen. Debbie Stabenow (D-MI) and Sen. John Barrasso (R-WY). S. 2613 is the Senate companion bill to the House version – H.R. 1290 – introduced by Congresswoman Barbara Lee (D-CA-13) last year. We encourage NASW members to continue to advocate for **S. 2613/H.R. 1290- Improving Access to Mental Health Act** by asking your Senators and Representative to cosponsor today! The NASW action alert for *H.R. 1484 the Social Worker Safety Act of 2017* is still active. This bipartisan legislation was introduced by Rep. Kyrsten Sinema (D-AZ-09) with original cosponsor, Rep. Elise Stefanik

(R-NY-21). With the help of your advocacy efforts, we are now up to 5 bipartisan cosponsors for H.R. 1484. We look forward to continued outreach to gain additional cosponsors for this vital piece of legislation.

NASW continues to push for support of *H.R. 1289, Dorothy I. Height and Whitney M. Young, Jr., Social Work Reinvestment Act,* which currently has 19 cosponsors.

Coalition and Collaborative Activities:

Social Justice staff attended the Spring meeting of the Board of Directors for the **National Commission on Correctional Health Care (NCCHC)** in Minneapolis. Staff represents NASW and the social work profession on the Board. This was a three-day meeting that included participating in discussions as a member of the Juvenile Committee and the Policy Committee.

NASW staff participated in a Capitol Hill meeting dealing with the **Opioid Crisis in the Black Community**. The meeting brought together a cross-section of academics, practitioners, legislators and advocates concerned about the impact of opioids in the African American community. NASW is committed to working with the group in future planning and problem-solving meetings.

NASW staff had preliminary discussions about collaborating with the Lawyers Committee for Civil Rights Under the Law on their **Stop Hate Project**. The project is designed to provide a hotline for individuals who are victims of hate crimes or serious hate-related incidents. This included hate associated with race/ethnicity, religion, gender, and sexual identity. The Lawyers Committee is asking NASW to help refine the hotline to address counseling and referring callers suffering from emotional (or physical) trauma from the hate-related incident.

NASW social justice staff attended a two-day national leadership gathering for the **Why Courts Matter Coalition** held in Des Moines, IA. The Coalition is comprised on over 50 organizations from many states who are concerned about nominations and appointments to the federal courts – including the Supreme Court. This was a planning meeting primarily for national organizations that have state affiliates (chapters). Several NASW Chapters have already participated in Courts Matters activities. The plan is to disseminate information and calls to action on key District, Circuit and Supreme Court nominations.

NASW is continuing its partnership with the CDC's *Tips From Former Smokers Campaign* to promote tobacco cessation. The American Lung Association and the University of Texas MD Anderson Cancer Center have released a new toolkit aimed at helping individuals understand what health insurance covers to quit smoking.

NASW participates in the Families USA Protect Our Care Coalition calls and activities.

Staff is participating in a coalition to advance the National Academies of Sciences, Engineering and Medicine consensus study, *Integrating Social Needs Care into the Delivery of Health Care to Improve the Nation's Health*. The National Academies is soliciting public comments to help inform the deliberations

of a consensus study committee. Written comments may be sent to socialneedscare@nas.edu and more information is available here.

Staff is participating in the National Navigation Roundtable Training & Certification Task Force with the American Cancer Society to advance competencies for Patient Navigation.

Staff is participating in work groups to promote comprehensive pain care through the Integrative Pain Care Policy Congress.

Staff attended a National Academy of Sciences workshop, Understanding and Overcoming the Challenge of Obesity and Overweight in the Armed Forces on May 7.

Staff attended the CMS Comprehensive Primary Care Plus National Meeting in Baltimore, MD on May 8.

Staff will participate in the Strategies to Overcome and Prevent (STOP) Obesity Alliance quarterly meeting on May 29.

The event was hosted by the National Coalition on Mental Health on Aging, of which NASW is a member, the National Association for Rural Mental Health, the National Association of County Behavioral Health and Developmental Disability Directors, and the National Association of Counties, in coordination with Congressional representatives Grace Napolitano (D-CA-32) and John Katko (R-NY-24), cochairs of the House Mental Health Caucus.
