Dear Chairmen Blunt & Cole and Ranking Members Murray & DeLauro -

We write to urge you to fund Title II-A of the Every Student Succeeds Act at its current level of \$2.295 billion, without negatively impacting funding for other education programs. This program is essential to providing an effective education for each student across the nation, as it invests in the development of and support for the profession that delivers on that commitment.

In 2015, the Congress completed a remarkable bi-partisan reauthorization process and enacted the Every Student Succeeds Act. An essential aspect of that reauthorization was the acknowledgement that the states and the educator profession must be supported, as they are essential in ensuring a sound education for all students regardless of income or location. States face significant challenges as they implement the law, including addressing critical teacher shortages in high need fields such as STEM and special education; recruiting and preparing the next generation of educators in the face of declining enrollment in teacher preparation programs; improving retention of teachers instead of replacing those who depart early in their careers; ensuring the equitable distribution of effective and experienced teachers and addressing the woeful underrepresentation of teachers of color in the education profession. Title II-A is the support states need to address these challenges enabling them to invest in evidence-based strategies such as the development of career ladders that include teacher leadership opportunities, strengthening instructional capacity for the workforce and innovative teacher and leader residency programs and in many cases, help school districts ensure that classrooms have teachers.

States are in the process of finalizing their plans on how they will use Title-II funds. They have gathered stakeholders from around their states – teachers, paraprofessionals, parents, local school officials, principals, specialized instructional support personnel, teacher educators, advocates and others – and

received input about how they can best address the unique challenges in their state using the flexibility of ESSA funding. The Department of Education will soon be reviewing those plans and states will be taking action to invest in the students and schools in their jurisdictions.

In his FY 2018 Budget Request, President Trump requested the elimination of funds for Title II-A. Such an elimination would leave states in a position of being unable to implement the new law and unable to effectively meet the needs of the students and the communities they serve. A strong federal investment upholds your commitment to states, to students and families, to local school districts and to teachers and school leaders. We urge you to lift the budget caps on non-defense discretionary spending set forth in the Budget Control Act so that you can continue to fund Title II-A at the \$2.295 billion level, without negatively impacting funding for other education programs.

Thank you for your consideration of this request and we look forward to working with you moving forward on education funding.
