<b>Finance and Budget</b>	
Received the National Office and Chapters’ Unaudited Financial Report approved the FY 2020-21 Form 990	<p>On the unaudited Statement of Financial Position as of February 28, 2022, the combined National Office and chapters net asset position was \$10.6 million. The components of the net asset are total assets of \$34.5 less total liabilities and deferred revenue of \$23.9 million. On the Statement of Activities total revenue from operations was \$23.0 million and total expenses were \$22.4 million for the reporting period. Chapters earned \$920,000 in operating income, which exceeded budget projections by \$492,000. Total chapter revenue was \$11.5 million.</p> <p>The Board approved for filing with the Internal Revenue Service, the FY 2020-21 Form 990.</p>
Accepted the FY 2020-21 Financial Audit	As recommended by the Audit Committee, the FY 2020-21 consolidated financial audit was accepted by the Board. The audit was presented as a “clean” audit, free of any material misrepresentations and meets the standards of the generally accepted accounting principles.
Approved the FY 22-23 Association Budget	As recommended by the Finance Committee, the Board approved the proposed FY 2022-23 Association budget.
