Dear Speaker Boehner and Leader Pelosi:

The undersigned national behavioral health organizations, representing consumers, family members, advocates, professionals and providers, urge you and your colleagues to reject the House Labor, Health and Human Services and Education Appropriations Bill (HR 3070) that guts funding for mental health and addiction services and supports by a whopping 8.4 percent – a crippling, irreversible cut that would take years to recover. This bill comes on the heel of cuts imposed in FY 2011 and only further decimates critical programs that ensure a strong public behavioral health infrastructure.

It is shocking and troubling that HR 3070 would single out behavioral health for such deep cuts at a time when states have cut back funding for mental health care by nearly \$3.4 billion over the last 3 years. This funding supports services which all play a critical role in helping individuals with, or at risk of, a mental health and/or substance use condition achieve recovery and live a productive life in the community.

The brunt of the cuts to public health included in the bill would be borne by the Substance Abuse and Mental Health Services Administration. In fact, HR 3070 cuts mental health funding by almost 25 percent – that would place their funding at the same level as nearly 12 years ago. The prevention portfolio at SAMHSA would be particularly hit hard at a time when the Institute of Medicine, in a 2009 report, declared that the prevention of mental health and substance abuse conditions among young people must be a national priority.

On the heels of the Arizona tragedy, more deaths from suicide (more than 34,000) than traffic fatalities, record number of suicides among servicemembers, a growing number of young people facing mental health and addiction problems (half of all people with a mental health condition will have the first onset by age of 14) and our youth and adults being overrepresented in the

criminal justice system, our nation's response to this crisis cannot nor should it be to decimate the principal agency dedicated to addressing this population.

Every day, we read about the impact on the behavioral health of Americans being exacerbated by economic problems and how funding for essential and basic services is dwindling. It is never a good idea to cut funding for mental health and addiction services, and this is an especially bad time that will only exacerbate what is a clearly a public health crisis.

In addition, we lament the zero-ing out of the Prevention and Public Health Fund in HR 3070 because it is critical to invest in proven prevention activities that we know will work to reduce health care costs and keep Americans healthier, including steps that promote integration of behavioral and overall health care and improve screening.

We are deeply troubled with the House approach to behavioral and public health funding and strongly urge Congressional Leaders to adopt the Senate's Labor, HHS spending bill crafted by Sen. Tom Harkin that takes a much more balanced approach by rejecting deep cuts to public health agencies.
